RULES FOR BURNING AS FOLLOWS

Open burning is allowed by permit only; and shall be issued on the discretion of the Bellevue Fire Department. Call 884-1077 to receive a permit. Permits may be picked up at The Village Office at 2828 Allouez Ave (920468-5225) from 7:30-4:30 M-F. Failure to obtain a permit may result in a citation.

BURNING IS ALLOWED: from SUNRISE to SUNSET and must be totally extinguished 1/2 hour before sunset.

NO BURNING shall be permitted within 25' of any structure. (To reduce this to less than 25' with an allowable minimum of 15' the fire must be smaller than 3' in diameter 2' in height) Provisions shall be made to prevent the fire from spreading.

NO FLAMMABLE LIQUIDS shall be permitted to ignite the fire (i.e. gasoline, kerosene, starter fluid, etc.) **NO BURNING** in road right-of-way

NO BURNING in windy or drought conditions. Wind speed must be less than 10 miles per hour **SIZE OF THE PILE** to be burned shall be no larger than 6' in diameter and 6' in height.

FIRE MUST BE ATTENDED at all times by someone 18 years of age or older with capabilities of extinguishing the fire. A fire extinguisher and/or charged garden hose must be ON SITE at all times. **NO BURNING** on construction sites.

Campfires must be smaller than 3' in diameter and 2' in height Dry seasoned wood only.

Remember burning is a privilege that may be revoked at any time. It shall be the option of the fire official that shall dictate the right to burn.

BURNING VIOLATIONS may be subject to fines in accordance with Village Ordinances.

RESPONSIBILITY The property owner, renter, lessee shall be held liable for any damage caused by any fire or recreational fire, including the cost of any citations.

MAY NOT BURN: petroleum products, plastic, rubber, shingles, tires, treated lumber (wolmanized, railroad ties, etc.), wet leaves, wet grass, furniture, cardboard, garbage, manufactured building products, OSB Structure Board, Fiberglass, and carpeting, anything that causes black smoke or an offensive odor.

LOSS OF PRIVILEGES AND/OR FINES MAY RESULT BY NOT FOLLOWING THE GUIDELINES
